- 1) Scheduling is first come first serve. To secure date and time host must submit within 5 business days of request to reserve date a signed agreement form and a non-refundable deposit of \$100. 00 Dates are not held in waiting more than 5 days.
- 2) Mail checks payable to: Carriage Shack Farm, LLC, 5 Dan Hill Rd, Londonderry, NH 03053. For Credit Card payment call (603) 716-0629.
- 3) Once deposit has been processed, confirmation will be sent by email to party host. PLEASE NOTE: Alterations to the package is not allowed once the deposit is received. Please contact us if you would like to add additional services. We cannot reduce the package agreed up.
- 4) Farm truck/trailer must be able to park within 50 feet of set-up area. Set-up and parking area should be reasonably level.
- 5) Total balance due is expected by the day of the party and prior to set-up or services will not be rendered.
- 6) Under no circumstance shall farm staff set-up without full payment in-hand. A single payment by cash or credit card is accepted.
- 7) Farm travels rain or shine. A 48-hour notice is required If cancellation is necessary. Reservation deposit will not be refunded if cancelled.
- 8) Party host is responsible for providing the appropriate supervision for all child attendees. Children cannot be left unattended at any time in pen area.
- 9) Party host accepts responsibility for the behavior of all-party goers including children and adults.
- 10) Safety of the animals and the people visiting the animals is of the utmost importance. Visitors are expected to follow the direction of farm staff. Unruly, unsafe and/or inappropriate behavior of any kind including but not limited to aggression towards the animals will not be tolerated. Posted rules shall be strictly observed. No Smoking or alcoholic beverages will be allowed near the animals. Farm staff reserves the right to restrict access to animals or ask individuals to leave pen area where the care and safety of the animals become a concern.
- 11) The party host is expected to support Carriage Shack Farm, LLC in matters where safety is of concern.
- 12) The party host expressly agrees to defend, indemnify, and hold harmless Carriage Shack Farm, LLC from and against any and all claims for loss or damage to personal property, or injury to, or death of person or persons arising in any manner out of use of products and services provided under this agreement.
