Farm staff will arrive approximately 1-2 hours before event time for set-up of Deluxe or Premium Petting Farm, and 20-30 minutes prior to Mini Petting Farm. Visitors are not allowed in pet area during set-up or break-down process.

The traveling farm comes equipped with pop-up shelter for shade or rain, hand sanitizer, pen(s), and an array of clean friendly farm animals. Farm staff provides a safe and inviting environment for visitors of all ages to enjoy. **1-hour minimum required for Mini Petting farm, 2-hours for Deluxe, 5-hours for Premium Petting Farm.**

Mileage Fee: \$2.50 per mile is calculated one way from farm address to event location address.

TERMS AND CONDITIONS:

- 1) Scheduling is on a first come first serve, desired date will not be held in waiting for more than 5 days.
- 2) To secure a date, a 30% deposit of subtotal and signed agreement form must be submitted within 5 business days of request to reserve a date. **PLEASE NOTE: DEPOSITS ARE NONREFUNDABLE.**
- 3) Once deposit has been processed, confirmation will be sent by email to primary contact.
- 4) **CANCELLATION FEE: 25% of the remaining balance will be charged if cancellation occurs within 2 weeks of the scheduled event – no exceptions.**
- 5) Mileage Fee: \$2.50 per mile calculated one-way from farm address to event location address.
- 6) **The remaining balance is expected one week in advance of the event, unless a payment arrangement is arranged with Carriage Shack Farm, LLC. Services will not be rendered without final payment in advance of arrival.**
- 7) A single payment by cash, check, or credit card will be accepted in paying final balance.
- 8) Farm truck and trailer must be able to park within 50 feet of designated set-up area.
- 9) Both parking and set-up area must be reasonably level.
- 10) No unauthorized personnel or visitors will be allowed in/on farm vehicles or equipment.
- 11) No unauthorized personnel or visitors will be allowed in pen area during set-up or break-down.
- 12) Traveling farm comes equipped with pop-up shelter for shade or rain, hand sanitizer, animal pen(s), and an assortment of clean, friendly farm animals.
- 13) Animal assortments listed may vary by season and is subject to change without notice.
- 14) Indoor set-up: for an additional fee – floor covering such as heavy canvas, rubber mats, etc., can be placed under pen area(s) as a barrier against animal foot-traffic. Though intended to provide some protection, it is not a guarantee against potential damage. Carriage Shack Farm, LLC provides no warranty against damage from animal foot-traffic to indoor flooring surfaces such as, but not limited to: wood gymnasium floors, vinyl plank or tile, laminate, concrete, ceramic, etc.
- 15) Schools & other youth organizations are responsible for providing appropriate supervision of the students/children under its charge. Students/children cannot be left unattended at any time in/near pen area. Organization accepts responsibility for the behavior of the students/children under its charge.
- 16) Safety of the animals and the people visiting the animal pens is of the utmost importance. Visitors are expected to follow the direction of the farm staff. Unruly, unsafe and/or inappropriate behavior of any kind including aggression toward the animals, or offensive language will not be tolerated in or around animal pens. Posted rules shall be strictly observed. No Smoking or alcoholic beverages will be allowed. Farm staff reserves the right to restrict access to animals or ask individuals to leave the pen area if direction from staff is being ignored or displayed behavior is deemed unsafe, inappropriate, and/or alcohol is suspected.
- 17) The organization and its authorized representatives or event coordinator are expected to support Carriage Shack Farm, LLC and its staff in all matters where safety is of concern.
- 18) The organization expressly agrees to defend, indemnify, hold harmless Carriage Shack Farm, LLC and members of its staff from and against any and all claims for loss or damage to personal property, or injury to, or death of person or persons arising in any manner out of use of products and services furnished under this agreement.
